DRIVES Layer Extension

- Badge awarded for a skill/competence or knowledge on certain level
- Layer 1: Maturity Level (1) Awareness; (2) Practitioner and (3) Expert Level Badges
- Layer 2: Concept Type (1) Skill/Competence or (2) Knowledge
- Layer 3: Type of Completion (1) Attendance; (2) Exam;
- Layer 4: Recognition
 - (1) Recognized certificate/training from recognized entity (by DRIVES project) is provided for the completed training course; (Gold Color) – based on the recognition criteria
 - (2) Unrecognized certificate/training is provided from unrecognized entity or not provided at all; (Grey Color) or DRIVES color

- Types of completion (does affect only the Badge description)
 - Attendance not a proof of learning
 - Exam course has been finished to a high standard
 - This could be type of the exam oral, test (depends how fine the granularity should be)


- DRIVES Badges are parallel to this certificate

 - ECTS credits: ECTS users' guide European Commission (europa.eu)
 - If course completion is connected to the ECTS credits, trainees will obtain Gold Badges
 - ECVET credits: <u>Necessary conditions for ECVET implementation (europa.eu)</u>
 - If course completion is connected to the ECVET credits, trainees will obtain **Gold Badges**
 - EQAVET implementation: <u>Home Eqavet</u>
 - This is specified during the provider registration and has no effect on the badges
 - Emblem is only shown in the provider detailed information
